



The **Institute of Forensic Psychology** invites applications for a Postdoctoral position. This is a 1 year, 40 hour per week commitment, postdoctoral clinical forensic fellowship for a pre-licensed individual seeking advanced training in evidence-based forensic clinical psychology practices and court ordered legal issues that commonly present for forensic evaluation. The justice involved client populations will consist of adults and adolescents within settings that include traditional residential, psychiatric, incarceration, and outpatient therapy settings. IFP is a forensic evaluation organization, with a teaching and education in forensic psychology division and research in forensic psychology division. There are opportunities in these divisions as one is possibly interested.

A Ph.D./Psy.D. in Clinical Psychology or Counseling Psychology is required. Other related doctoral psychology backgrounds may also be considered. Individuals who fill this role will gain valuable experience in conducting a variety of forensic evaluations among a diversity of populations served by IFP and its affiliates. This individual will learn the overall process from referral to the final conclusions of a forensic examination, based on current statutes, legal guidelines and forensic psychological practice. The successful candidate will be able to accrue postdoctoral hours towards licensure through clinical supervision by a IFP Psychologist who is a licensed clinical forensic psychologist with expertise in interdisciplinary, collaborative evaluation models among adolescent and adult populations. Postdoctoral fellows are expected to also participate in individual and group supervision each week.

Required Qualifications:

- Ph.D./Psy.D. in Clinical Psychology, Counseling Psychology or another related doctoral program, from an APA-accredited graduate program.
- Completion of pre-doctoral internship at APA-accredited site. Non-accredited completion sites may be considered.

Preferred Qualifications

1. Skill and experience in providing psychological clinical and evaluation services to justice involved clients and/or clients with acute or chronic psychological problems.
2. Advanced training in various evidence-based approaches to forensic evaluation with adolescents and adults.
3. Advanced training in evaluation methods in psychology with adults and adolescents.
4. Knowledge of state and federal laws and legal requirements.
5. Knowledge of psychological and psycho-legal testing
